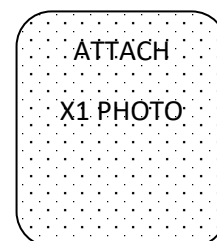

RELEASE OF LIABILITY, WAIVER OF CLAIMS & INDEMNITY

To release the officials, directors, employees, representatives, agents, sponsors and volunteers of the Royal Cape Yacht Club from any liability and responsibility, whatsoever, for any claims or causes of action that I, my estate, heirs, executors or assigns may have for personal injury, damage or loss to property or wrongful death arising from my participation in the Royal Cape Yacht Club sailing, arising from any cause whatsoever.

By executing this document, I, in my personal capacity agree to hold the Royal Cape Yacht Club or any persons set out in paragraph 2 above, harmless for any injury or loss of life or damage to property, which may occur directly or indirectly in connection with my participation in the Royal Cape Yacht Club sailing and indemnify them against any and all claims which may arise in this regard.
